1. Masta Rural Municipality Bhatekhola Bajhang Invites Electronic Bids from eligible bidders for the construction of ***Dhadar Masta Mandu Reconstruction works*** Construction works under national competitive bidding –Single stage two envelope bidding proceders.

Only Eligible bidder with the following key qualifications should participate in the bidding:

Minimum Average annual construction turnover of the best 3 years within the last 10 years:  
3,98,00,000/-

Minimum Work Experience of similar size and nature : 10600000/-

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of [Masta Rural Municipality Bhatekhola Bajhang, Sudurpaschim Province, Nepal] or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. A complete set of Bidding Documents may be purchased from the office [Masta Rural Municipality] and the office [Masta RM-4, Bhatekhola Bajhang] by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000/-Nrs till 9 April. 2026, 12:00 during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at **Masta Rural Municipality Bhatekhola Bajhang Sudurpaschim Province Nepal** at March-31-2026, 12:00 hours
6. Sealed or electronic bids must be submitted to the office **Masta Rural Municipality Bhatekhola Bajhang, Sudurpaschim Province, Nepal** by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 9 April, 2026, 12:00 hours. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 9 April, 2026, 13:00 hours at the office of **Masta Rural Municipality Bhatekhola Bajhang, Sudurpaschim Province, Nepal**. Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs. 7,00,000/-**, which shall be valid for 30 days beyond the validity period of the bid .
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
